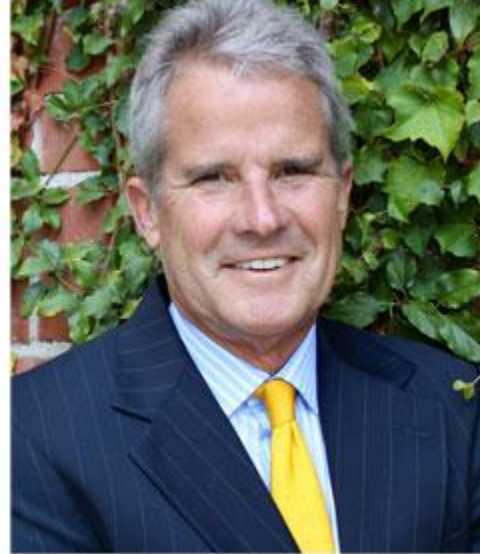




Jerry Bieser and Tom Davis named new trustees by the Laguna Beach Community Foundation Board of Trustees
